



Under normal conditions of use, the electrode materials and liquid electrolyte they contain are not exposed to the outside, provided the battery integrity is maintained and seals remain intact. Risk of exposure only in case of abuse (mechanical, thermal, electrical) which leads to the activation of safety valves and/or the rupture of the battery containers. Electrolyte leakage, electrode materials reaction with moisture/water or battery vent/explosion/fire may follow, depending upon the circumstances.

Section 4- First Aid Measures

Eyes: Irrigate thoroughly with water for at least 15 minutes. Obtain medical attention.

Skin: Wash off skin thoroughly with water. Remove contaminated clothing and wash before reuse. In severe cases obtain medical attention.


Section 5- Fire Fighting Measures

Accidental: If the battery breakage and electrolyte leakage, evacuate personnel until the smoke cleared. Wipe with a cloth and placed in steel drums into the bag inside. If the battery is hot, away from the scene firstly, cool the battery, so that the steam dissipated. Adequate ventilation. Avoid skin or eye contact steam.

Waste treatment: The battery Should discharge completely, the waste batteries will be turned over in the relevant sector, and all waste must refer to the United Nations, national, local regulations for disposal. Reference to national or federal Environmental Protection Agency EPA.

Stored in a dry, cool and ventilated environment, to avoid temperature changes or high temperature.

Keep away from heat, avoid prolonged sun exposure.

Against short circuit, overcharge, forced discharge, or in a fire.

Battery disassembly, crush, fire or high temperatures can cause fire or explosion, prohibit short-circuit or error operation.


Hazardous reactions may occur under some specific conditions.

Section 14 – Transport Information

According to PACKING INSTRUCTION 965 Section II of IATA DGR 61th Edition for transportation, the special provision 188 of IMDG (incAmdt 39-18). The batteries should be securely packed and protected against short-circuits. Examine whether the package of the containers are integrate and tighten closed before transport. Take in a cargo of them without falling, dropping, and breakage. Prevent collapse of cargo piles. Don't put the goods together with oxidizer and chief food chemicals. The transport vehicle and ship must be cleaned and sterilized otherwise it is not allowed to assemble articles. During transport, the vehicle should prevent exposure, rain and high temperature. For stopovers, the vehicle should be away from fire and heat sources. When transported by sea, the assemble place should keep away from bedroom and kitchen, and isolated from the engine room, power and fire source. Under the condition of Road Transportation, the driver should drive in accordance with regulated route, don't stop over in the residential area and congested area. Forbid to use wooden, cement for bulk transport.


